DESCRIPTION OF WORK:

This position's responsibilities are in the areas of providing protective, investigative, counseling and case management services for children who are at risk for neglect and/or abuse. Work involves assessment of alleged neglect and abuse, substantiation of the alleged neglect or abuse as prescribed by federal and state guidelines, providing testimony in court hearings, and following-up with case management and preventive services for clients. Employee analyzes situations and determines appropriate courses of action immediately or in short time spans and often under very stressful conditions. Employee may provide group, family or individual treatment to clients of any age and with any developmental, mental health, medical, financial or family problems.

Minimum Training and Experience Requirements: - Master's degree from an accredited school of social work and one year of social work experience; or a Bachelor's degree from an accredited school of social work and two years of social work or counseling experience; or Master's degree in a counseling field and two years of social work or counseling experience; or a four-year degree in a human services field or related curriculum and three years of social work or counseling experience; or graduation from a four-year college or university and four years of experience in rehabilitation counseling, pastoral counseling or a related human service field providing experience in the techniques of casework, group work or community organization; or an equivalent combination of training and experience. One year of work experience can be credited for completion of the social work collaborative.

PREFERENCES: Prefer applicants with social work experience in a Department of Social Services and a Human Services Degree; or social work experience in a human services setting and a Human Service Degree; BSW or MSW Degrees, or a human services related master's level degree.
